


COMMERCIAL ITEM DESCRIPTION
SPECIFICATION SHEET

OIL DRIP PAN, METAL, RECTANGULAR

The General Services Administration has authorized the use of this commercial item description (CID) for all federal agencies.

The complete requirements for procuring the oil pan, drip, metal, rectangular, described herein shall consist of this document and the issue in effect of CID A-A-59775.

CLASSIFICATION/PART OR IDENTIFICATION NUMBER (PIN). This CID uses a classification system which is included in the Part Identification Number (PIN) as shown in the following example (see NOTES).



SALIENT CHARACTERISTICS.

Interface and physical dimensions. Oil pans, drip, metal, rectangular, supplied to this CID shall be as specified herein (see figure 1).

Size. The physical dimensions of this oil pan drip, metal, rectangular, are: length: 47 inches (119.38 cm), width: 25 inches (63.5 cm), height: 0.5 inches (1.27 cm).
