




Dimensions: Shall conform to NEMA WD 6, configuration L15-30P.

Mating face: Dead-front construction.

Armored construction: Not acceptable.

Ratings:

Voltage: 250 volts.


Current: 30 amperes.

Frequency: 50/60 hertz, 3-phase.

Mating connector: W-C-596/128 and W-C-596/130.

Strain relief: Accommodate cable diameter .625 - 1.050 inch.

Part or Identifying Number (PIN): The PIN consists of the prefix W-C, the basic specification number, the specification sheet number, and the style number.
