

REQUIREMENTS:

Design and configuration: See figure 1.

Mating Face: Dead – front construction.

Armored construction: Not acceptable.

Ratings:

Voltage: 28 volts.

Current: 30 amperes.

Frequency: Direct current

Vibration: Method 204 of MIL-STD-202, test condition B (WC596/149-2 only).

Shock: Method 213 of MIL-STD-202, test condition I (WC596/149-2 only).

Mating connector: W-C-596/148 and W-C-596/150.

Strain relief: Accommodate cable diameter .296 - .625 inch (7.52 - 15.88 mm).

Part or Identifying Number (PIN): The PIN consists of the prefix W-C, the basic specification number, the specification sheet number, and the style number.


