

Voltage: 120/208 volts, 3 phase Y.

Current: 30 amperes.

Frequency: 400 hertz.

Vibration: Method 204 of MIL-STD-202, test condition B (WC596/158-2 only).

Shock: Method 213 of MIL-STD-202, test condition I (WC596/158-2 only).

Mating connector: W-C-596/157 or W-C-596/159

Part or Identifying Number (PIN): The PIN consists of the prefix W-C, the basic specification number, the specification sheet number, and the style number.


