



1. SCOPE

1.1 Scope. This drawing documents the general requirements of a high performance hex Schmitt-trigger inverter microcircuit, with an operating temperature range of -55°C to +125°C.

3. REQUIREMENTS

3.1 Marking. Parts shall be permanently and legibly marked with the manufacturer's part number as shown in 6.3 herein and as follows:

- B. Pin 1 identifier
- C. ESDS identification (optional)

3.2 Unit container. The unit container shall be marked with the manufacturer's part number and with items A and C (if applicable) above.





FIGURE 2. Truth table.





FIGURE 3. Logic diagram.
